MeGreen promotion

From July 15th until August 31st 2022, new and existing customers will be eligible for the following bonuses after opening a new MeGreen investment plan:

- €40 cash premium on the cash account of the customer, and
- In collaboration with the non-profit organisation Bwoods, MeDirect will plant 5 trees for each opened MeGreen investment plan.

The minimum amount to open a MeGreen investment plan is €2.500. Furthermore, customer may choose to invest further with a monthly contribution of at least €100.

The actual investment of at least €2.500 needs to be done before the end or the early termination of the campaign.

Customers who choose to open a MeGreen investment plan through a joint account will only be eligible once for the bonuses. If one of the co-owners of an account opts to open another sole MeGreen investment plan, (s)he will not be eligible for the bonus.

Every customer is only eligible to receive the bonus once. Opening multiple new MeGreen investment plans will not result in multiple bonuses.

MeGreen investment plans can only be opened through the desktop version of the MeDirect platform, and not through the mobile app.

- Bonus

The bonus will be paid out latest 14 working days after the investment has been done and the funds have been added in the portfolio.

- Planting trees

In collaboration with Bwoods, MeDirect commits to plant 5 trees for each eligibly opened MeGreen investment plan. Bwoods is a non-profit organisation with the goal to buy and plant trees through

donations and therefore create ecosystems which make a significant difference in our environment. MeDirect will, in coordination with Bwoods, determine a location where the trees will be planted.

Terms and conditions of participation

MeDirect reserves the right to refuse customers in accordance with its customer acceptance policy and the applicable anti-money laundering and KYC legislation.
