2. WHAT ARE COOKIES?

Cookies are small pieces of text that are stored on the hard drive of your computer, tablet or mobile phone by your browser. You can control how websites use cookies by configuring your browser's privacy settings. Learn more about cookie controls at the bottom of this page.

3. WHAT ARE COOKIES USED FOR?

To enhance your user experience, MeDirect Bank SA uses cookies for the purposes described below:

- Keeping track of information you have provided to us for example when filling out a form and
 proceeding to the next step, the website remembers what you have done in the previous step.
- · Remembering your preferences or where you left off in your use of the website
- Measuring your use of the website so that we can improve them, tailor our websites to your likely interests
- Understanding your likely interests so we can provide you more relevant ads and content on non-MeDirect Bank SA websites and in non-MeDirect Bank SA apps
